



2024-2025 DANCE STUDIO TERMS & CONDITIONS

FEES & PAYMENT

1. Your initial registration includes a one-time \$99 fee.
2. You are responsible to set-up your monthly AutoPay through our website. Dance Fees are prorated into equal monthly payments August 2024-April 2025. If you join our studio after August 5, 2024 your fees will be prorated into equal monthly payments starting the month of your initial enrollment. Additional fees will apply to dancers who start on or after October 1.
3. Automatic Payments will process monthly on the same numerical date each month based on the date you set it up.
4. If you would like to opt out of AutoPay, manual payments are an additional \$15/month due to the added cost of manually invoicing and following up on payment with the student and/or parent. Personal checks, money orders, and exact cash are priced as manual payments and must be received by your first class of the month. Payments more than seven days overdue will be assessed a \$40 late fee.
5. You may pay for the season in half or in full, which will not incur additional fees regardless of payment type.
6. Pre-Season Cancellation Policy: A Full Refund (minus credit card fees) will be given if cancellation is received prior to July 10, 2024, 50% refund (minus credit card fees) will be given if cancellation is received between July 11-24, 2024, and no refund will be given for cancellations received after July 24, 2024.
7. Within Season Cancellation Policy: Notify the Center for the Arts at least 30 days in advance of your next payment due date.
8. Documentation for ESA funding is available upon request. Note: We will not refund fees submitted for ESA reimbursement.

13. I understand all dancers will be required to schedule paid private dance lessons if more than 2 classes are missed January-April 2025.
14. Refunds will not be issued due to student tardiness
15. Refunds will not be issued due to missed classes
16. Refunds will not be issued if a student is sent home due to illness or behavior
17. If a dance teacher misses a class and a sub or make-up class is not provided, you will be refunded for that class session.
18. COVID-19 UPDATE: In the event of a shutdown due to COVID-19 or other widespread pandemic, lessons will automatically shift to virtual classes via Zoom/FaceTime/Skype. Students will still be required to put in a 30-day notice to stop classes and a refund will not be given for payments that have already been made up to that point. Our hope is that another shutdown is not required and we will do everything possible to provide a safe in-person lesson experience.
